

**AN ORDINANCE AUTHORIZING THE EXECUTION OF A MUNICIPAL HOUSING AND COMMUNITY DEVELOPMENT COOPERATIVE AGREEMENT BETWEEN THE VILLAGE OF TWIN OAKS AND ST. LOUIS COUNTY BEGINNING IN FISCAL YEAR 2011:**

**WHEREAS**, on May 5, 2010, the Village of Twin Oaks held a Public Forum regarding entering into this Program under the eligible activities associated with Community Development and Housing Assistance Programs in accordance with St. Louis County's Community Development Block Grant Program; and

**WHEREAS**, in order to participate in this program, St. Louis County must submit each year a Consolidated Plan approved by the Department of Housing and Urban Development (HUD), and

**WHEREAS**, participating communities in St. Louis County are required to enter into and or amend each year a Cooperative Agreement with St. Louis County to reflect changes in this Plan; and

**NOW THEREFORE**, BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE VILLAGE OF TWIN OAKS, MISSOURI, AS FOLLOWS:

**SECTION ONE:** The Chairman of the Board of Trustees is hereby authorized to execute the attached Municipal Cooperative Agreement with St. Louis County, which is incorporated herein by reference as Exhibit "A".


**SECTION TWO:** All ordinances or parts of ordinances in conflict with this Ordinance are hereby repealed.

**SECTION THREE:** This Ordinance shall become effective as provided herein and shall be printed in the Municipal Code of the Village of Twin Oaks.
