AN ORDINANCE AMENDING TITLE VI, SECTIONS 600.010, 600.020 AND 600.160 (ALCOHOLIC BEVERAGES), SECTIONS 605.010 AND 605.140 (BUSINESS AND OCCUPATION LICENSES AND REGULATIONS) AND 610.070 (AMUSEMENT CENTERS AND ARCADES) BY AMENDING AND ELIMINATING CERTAIN DEFINITIONS AND LICENSE REFERENCES TO COMPLY WITH CURRENT STATE LAW

BE IT ORDAINED, by the Board of Trustees of the Village of Twin Oaks, as follows:

SECTION 1: TITLE VI, SECTION 600.010 of the Municipal Code is hereby Amended in the following respects:

- A. By deleting the phrase "except for non-intoxicating beer as defined in this Section" from the first sentence of the definition of *INTOXICATING LIQUOR*.
- B. By deleting in its entirety the definition of *MALT LIQUOR* and substituting in its place the following:

MALT LIQUOR: An intoxicating liquor containing alcohol not in excess of five percent (5%) by weight manufactured from pure hops or pure extract of hops, or by pure barley malt, or wholesome grains or cereals, and wholesome yeast, and pure water.
- C. By deleting in its entirety the definition of *NON-INTOXICATING BEER*.
- D. By deleting the phrase "or non-intoxicating beer" from the first sentence of the definition of *ORIGINAL PACKAGE*.

SECTION 2: TITLE VI, SECTION 600.020 is repealed in its entirety and a new SECTION 600.020 adopted in its place to read as follows:

SECTION 600.020 MINORS PURCHASING OR POSSESSING
INTOXICATING LIQUOR

Any person under the age of twenty-one (21) years, who purchases or attempts to purchase, or has in his/her possession, any intoxicating liquor is guilty of an offense.

SECTION 3: TITLE VI, SECTION 600.160 is repealed in its entirety and a new SECTION 600.160 adopted in its place to read as follows:

SECTION 600.160 OTHER LICENSES MAY BE REQUIRED
FOR OTHER BUSINESS ACTIVITIES

The license required by this Article shall be in addition to and independent of any other licenses required by the Village.

SECTION 4: TITLE VI, SECTIONS 605.010, Subparagraph 7, 605.140 and SECTION 610.070, Subparagraph B are amended as follows:


By eliminating the words “non-intoxicating beer” or “non-intoxicating beer” wherever they appear in said SECTIONS and by inserting the connective “or” preceding the words “malt liquor” in SECTION 605.140.

SECTION 5: In all other respects said SECTIONS as modified and Amended herein are ratified, confirmed and re-published.

SECTION 6: The provisions contained in this Ordinance shall be printed in the Municipal Code.

SECTION 7: This Ordinance shall be in full force and effect from and after its passage as by law provided.
